It is further notified that all applications with stipulated time during this Mega Block and all dates in NGDRS and Seva Setu will be automatically extended and rescheduled to next 15 days respectively.

In cases of extreme emergency, District Commissioner/District Registrar of jurisdictional district may direct to provide specific services in offline mode with prior permission of DLR&S/IGR with necessary record keeping for mainstreaming in the digital system when it resumes functioning. DLR&S/IGR will issue standard operating procedure in all cases where such permissions are granted.

Necessary awareness generation using print, electronic and social media along with inter personal communication shall be undertaken by DLR&S centrally and District Commissioners in their district for minimizing the public inconvenience at all levels.
