With reference to the above regarding Implementation of CM's Special Scheme for Rehabilitation of Erosion affected families, I am to inform you that reports and beneficiary lists received from some of the districts show several discrepancies in the reports and the lists. Besides, the beneficiary lists are also seen to be incomplete, incorrect and not clear in all respect.

It has therefore, been decided to call the Additional Deputy Commissioners looking after the subject in the district alongwith the concerned Revenue Circle Officers to this office for a complete examination of the lists, reports etc and point out the defects noticed. After the said scrutiny, the lists will be returned to the districts for resubmission properly with due approval from the District Level Committee and under the signature of the Deputy Commissioner for necessary consideration at this end.


The detailed schedule for scrutiny of the beneficiary lists etc districtwise, is enclosed herewith as Annexure- "A".

You are requested to depute your Additional Deputy Commissioner and Circle Officers accordingly and ensure compliance.
